2021 RedMax MAPP AND INTERNET POLICY

Because Husqvarna Professional Products, Inc. (“Husqvarna”) believes that the performance, high quality and other attributes of its products are best conveyed by advertising that focuses on these features, and because Husqvarna desires to preserve the brand image associated with its Husqvarna® and RedMax®, products (collectively, the “Products”), Husqvarna has adopted this Minimum Advertised Price Policy (“MAPP”) to support advertising that promotes these objectives.

This policy applies to authorized dealers and other retailers (collectively, “Resellers”) of any Products in the United States. It does not apply to any Resellers selling products outside the United States. All authorized wholesalers are required to ensure that their respective authorized dealers comply with this policy.

The MAPP is a unilateral policy of Husqvarna. Husqvarna will determine whether a violation of the MAPP has taken place, and it will do so in its sole and absolute discretion and independent judgment. Husqvarna will also unilaterally enforce this policy in its discretion.

It is a violation of the MAPP for an authorized Reseller to advertise any Product at a price that is more than \$0.95 below the current Minimum Advertised Price (as defined below) or MSRP for such product. In addition, any advertising that, although in technical compliance with the terms of the MAPP, violates the spirit and intent of this policy (as reasonably determined by Husqvarna) shall be deemed a violation of this policy. Husqvarna reserves the right to make any changes it deems necessary to this policy from time to time.

1. COVERED MEDIA

This policy applies to all forms of advertising including, but not limited to the following (collectively, “Covered Media”):

- Print advertisements (inserts, magazines, catalogs, newspapers, etc.)
- Broadcast advertisements (radio and television)
- Direct mail, including e-mail
- Faxes
- Internet advertisements
- Billboards

The MAPP does not apply to (and the term “Covered Media” does not include) the following:

- In-store displays, in-store banners, in-store price markings
- Quotes, contracts, governmental bids

2. COVERED PRODUCTS AND APPLICABLE MINIMUM ADVERTISED PRICE

From time to time, Husqvarna will publish a list identifying:

- The Products subject to the MAPP (the “Covered Products”);
- The period of time such Covered Products are subject to the MAPP; and
- The applicable minimum advertised price (the “Minimum Advertised Price”) for such Covered Products.

Husqvarna may modify or change the Covered Products, the Minimum Advertised Prices, and any other provision of the MAPP at any time, without prior notice, such changes and modifications to be effective upon the date such changes are first published. Upon withdrawal of a covered product from the MAPP (as set forth on any such updated list), the MAPP shall no longer apply with respect to such product.

The MAPP applies to new, in-box current and discontinued or obsolete products. For example, if a new version of the 455 Rancher is introduced, the MAPP will apply to both the new version and to the prior versions.

The MAPP does not apply to parts and accessories, used equipment, or “scratch & dent” inventory as long as the advertisements in question specifically and conspicuously identify the products in question as such.

3. ROBOTIC MOWER SALES

Sales of Robotic Mowers, such as Automowers® are subject to this MAPP and Internet Policy. Unless otherwise indicated, the MAPP for robotic mowers will include installation; no robotic mowers may be sold online unless they are sold with installation included. Robotic mowers sold in a store may be sold with or without installation, but

advertisements, particularly online advertisements, may not reference a lower price without installation (i.e. must always display MAP), and online sales with pickup in store may not be made at any price lower than MAP.

4. SKU NUMBERS

Complete product SKU numbers, as they appear in the published list for current, prior, or discontinued models, must be clearly shown or announced on all advertisements in all Covered Media.

5. CERTAIN ADVERTISEMENTS NOT VIOLATIVE OF MAPP

The following advertisements shall not (absent other circumstances) constitute a violation of the MAPP:

- Advertising without any reference to price
- Advertising that states "Call for Price" or similar statements requiring the purchaser to call the authorized Reseller's physical location (as long as the Minimum Advertised Price is not juxtaposed with the term "Call for Price" or similar statements to create the implication that the Products will be sold for less than the Minimum Advertised Price).
- Advertising that promises to match or beat prices from competitors
- Advertising that offers free delivery with purchase, free training with purchase, or free service with purchase, unless the ad specifies a dollar value for these activities which nets a price that is below the applicable Minimum Advertised Price.
- Advertising that offers free or low interest financing, or no money down, or delayed payments unless the ad specifies a dollar value for these terms which nets a price that is below the applicable Minimum Advertised Price.

Bundling: Advertising the sale of more than one Covered Product in a bundled offering violates the MAPP unless the advertised bundled price equals or exceeds the total price of all of the individual Covered Products in the bundle. Free goods are permitted in a bundled offering if the Net Price of the Covered Products is not below the MAPP price, i.e., the cost or value of the free good cannot be subtracted from the advertised MAPP price of the Covered Products in the promotion.

"Add to Cart for Price" or similar advertising. Resellers may not use any language in online advertising which indicates or implies that a lower price may be available when a purchaser places a product in an online shopping cart or otherwise places an order. Additionally, Resellers may not change the Minimum Advertised Price when a Covered Product is placed in an online shopping cart or otherwise purchased online.

6. INTERNET SALES AND ADVERTISING

Advertising on the Internet is subject to and must comply with this MAPP. Advertising and/or sales of any Covered Product on any third-party retail site except amazon.com are strictly prohibited. Any sales or advertisements on other third-party retail sites, including Sears.com, Walmart.com, newegg.com, or similar, are strictly prohibited. This applies even if fulfillment is made by the Reseller.

Resellers wishing to sell online must post prominently the following information in their advertisement:

- (i) Their return policy
- (ii) Their shipping policy
- (iii) Information on how to receive after-sales service/warranty repairs
- (iv) The full contact name, address, and phone number of applicable sales and service personnel

Resellers who use trade names on amazon.com that vary from their corporate or Reseller retail location name must provide Husqvarna in writing with any and all trade names that are so utilized. Failure to comply with this requirement will be considered a violation of this MAPP.

Only Internet Qualified Products May Be Sold and Shipped. For product safety and quality reasons, Resellers may only sell online and ship those specific products, parts and accessories that have been approved by Husqvarna for Internet sales as determined by Husqvarna that are set forth on Exhibit A, as may be amended from time to time by Husqvarna. (collectively, "Internet Qualified Products").

In general, Internet Qualified Products are products that do not require pre-assembly or other pre-operating service, and which Husqvarna does not anticipate an unreasonable risk to the ordinary, reasonable consumer if sold without the in-person assistance of qualified sales and service personnel. The foregoing limitation is not intended to prevent Resellers from advertising products other than Internet Qualified Products online if: (i) it is made clear in such advertising that, while the sale transaction may occur online, the Products may only be picked.

up in the Reseller's physical location (i.e. "Sell online, pick-up in store") or personally delivered by the Reseller's personnel, and (ii) all pre-delivery service required by Husqvarna's stated policies and instructions has been performed by the Reseller.

Any product shipments made pursuant to an online sale must include all operator's manuals and any other standard documentation and accessories, to no lesser extent than such documentation and accessories would be included with a sale made from a Reseller's physical location (and as otherwise may be required by Husqvarna policies and instructions).

Resellers must ensure proper packaging, handling and labeling of any Products shipped pursuant to an online sale, including applicable country of origin hazardous materials warnings.

Use of Husqvarna Group Trademarks. Husqvarna's parent company owns several brands, including Husqvarna[®], Jonsered[®], RedMax[®], Poulan[®], Poulan Pro[®], Weedeater[®], and McCulloch[®]. The brand names are exclusive trademarks of the Husqvarna Group, and thus these names, or any derivative thereof, may not be used in any Reseller URL.

7. NO SALES OUTSIDE THE UNITED STATES

Products sold outside of the United States may have different warning label requirements, user manuals, environmental, or other compliance standards, warranties and/or legally mandated technical specifications from those sold within the United States. For these reasons, no Resellers located within the United States (or any of its territories) may sell or ship any Products outside the United States. Any such sale in violation of this policy cannot be supported by any service warranty offered by or through Husqvarna, notwithstanding any warranty provided in any information in the manual or package. Government sales to locations under the Status of Forces Agreement (SOFA), to US embassies, or into zones of military conflict are permitted.

8. NO SALES OF NON-CARB COMPLIANT PRODUCTS IN CALIFORNIA

The California Air Resource Board (CARB) has enacted emissions and air-quality regulations (including labeling requirements) that are different from, and more stringent than the requirements applicable to the remaining 49 States. The sale or importation of non-compliant products into California can subject Husqvarna and the Reseller to substantial fines and penalties. Accordingly, no Reseller located outside of California may make any sales or shipments of Products into California unless such products are CARB compliant, and the Reseller has received written permission from Husqvarna to make such sales or shipments. Violators of this policy will be liable to Husqvarna for any and all costs arising out of a violation of this section, including costs of recall and replacement of non-compliant products.

9. NO SALES TO RE-SELLERS

For product safety and quality reasons, without Husqvarna's prior written consent, Resellers may sell Products only to end-users and may not make any sales to persons or entities who the Reseller knows, or reasonably should know, intends to purchase such Products for resale, or otherwise intends to resell or pass the Products along to another entity or an end-user.

10. PROMOTIONS

From time to time, Husqvarna may offer special retail promotions such as manufacturer cash rebates or other incentives (a "manufacturer sponsored promotion"). For Covered Products, the amount of the cash rebate (or other promotion) provided by such manufacturer sponsored promotion may be used in conjunction with the published Minimum Advertised Price to reduce (during the time of such manufacturer sponsored promotion) the net retail price; however, the retail price and separate manufacturer sponsored promotion must be identified or called out separately as shown in the illustration below. Example: 455 Rancher: MSRP \$439.95, save \$20.00, sale price \$419.95!

11. QUESTIONS REGARDING THE POLICY

All questions regarding the MAPP shall be addressed to the MAPP administrator at Husqvarna@maptrackers.com. No other Husqvarna representative is authorized to confirm compliance with this policy, discuss it, or amend it. Husqvarna will not respond to any questions or comments from one authorized Reseller about the activities of any other authorized Reseller.

12. OTHER RESTRICTIONS STILL APPLY

The limitations and conditions set forth in this MAPP are in addition to and not in lieu of any obligations, limitations and conditions that may be imposed on a given Reseller, including pursuant to any agreement with the Reseller or otherwise.

13. RIGHT TO AMEND MAP POLICY

Husqvarna reserves the right to make all amendments to this MAP Policy as it may determine to make in its sole discretion, such changes to be effective immediately upon notice to the Reseller to the maximum extent permitted by applicable law.

14. CONSEQUENCES OF VIOLATIONS

Authorized Resellers advertising products in violation of this MAPP, in Husqvarna's sole discretion, will be subject to the following:

- First violation: Husqvarna will send a warning notice with an explanation of future consequences for continued or successive violations. This warning notice will provide the authorized Reseller with 48 hours to cure (e.g. take down from the Internet) the identified violation(s). Within five business days, the Reseller must also sign and return the notice to indicate that it:
 - (i) understands this policy;
 - (ii) has cured (e.g. taken down from the Internet) the identified violation(s);
 - (iii) understands that a subsequent violation may result in measures which include termination of the dealership.

A failure to cure or provide the requested response will be considered an additional violation.

- Second violation: Husqvarna will send a second warning notice that will provide the authorized Reseller with 48 hours to cure (e.g. take down from the Internet) the identified violation(s). A second violation may result in such penalties as the reduction or elimination of the Reseller's promotional support or growth incentive for a full year from the date on which the violation occurred, or the Reseller will not be authorized to place orders for the violating SKUs for 60 days or more, depending upon the scope of the violation. The Reseller will be provided five business days to sign and return the notice to indicate that it:
 - (i) understands this policy;
 - (ii) has cured (e.g. taken down from the Internet) the identified violation(s);
 - (iii) understands that a subsequent violation may result in measures which include termination of the dealership.

A failure to cure or provide the requested response will be considered an additional violation.

- Third violation: Husqvarna will consider a third violation as cause for termination, and reserves the right to enforce its full rights and remedies, including and up to termination, under the applicable agreement and state laws.

In cases involving egregious violations or habitual violators, Husqvarna may elect to bypass one or more of the steps listed above.

Husqvarna reserves the right to determine whether a violation of the MAPP has taken place, and it will do so in its sole and absolute discretion and independent judgment. Husqvarna will unilaterally enforce this policy in its discretion.

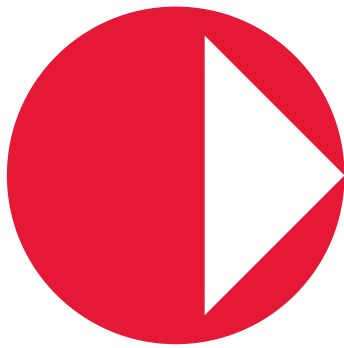
Most Parts & Accessories are Internet Qualified Products. Examples include but are not limited to:
