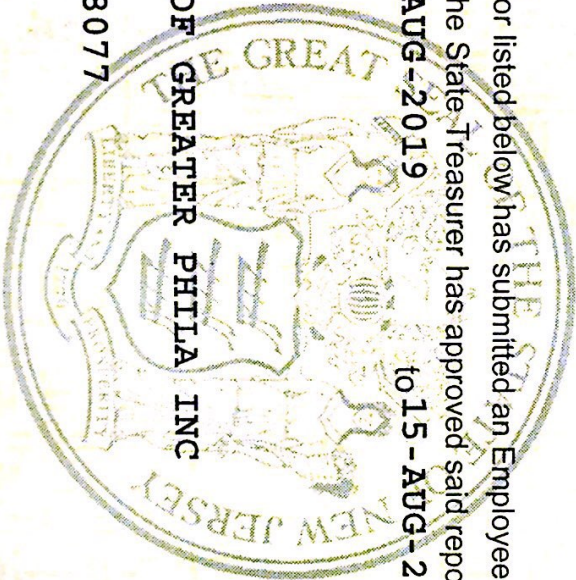


APPENDIX A




