GOODS, PROFESSIONAL SERVICE AND GENERAL SERVICE CONTRACTS

During the performance of this contract, the contractor agrees as follows:

APPENDIX A
AMERICANS WITH DISABILITIES ACT OF 1990

Purpose of Form


