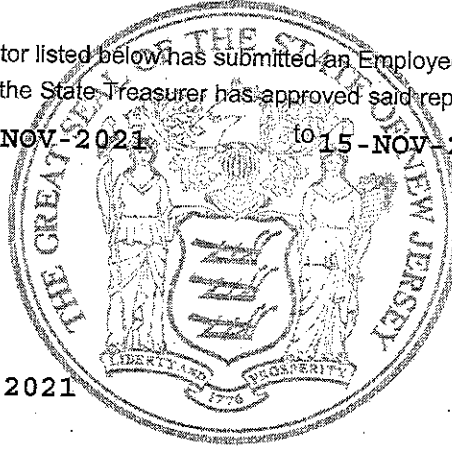

MANDATORY EQUAL EMPLOYMENT OPPORTUNITY LANGUAGE
