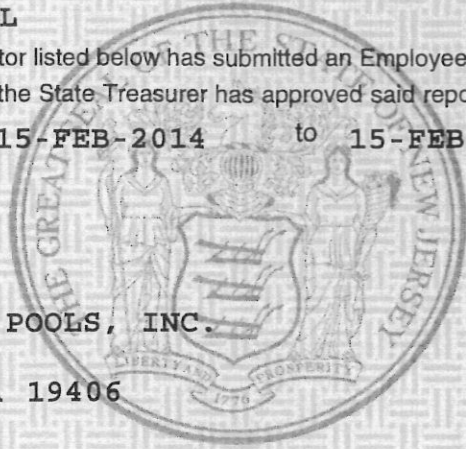




**AMERICANS WITH DISABILITIES ACT OF 1990
Equal Opportunity for Individuals with Disability**
