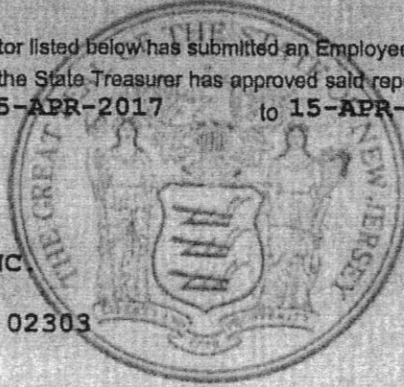

**MANDATORY EQUAL EMPLOYMENT OPPORTUNITY LANGUAGE
